Waste Electrical And Electronic Equipment Regulations 2013 ("The Regulations") Application For Approval Of An Authorised Treatment Facility – Regulation 61 (2) Approval Number: WEE/SE2202PA/ATF

Following your application for approval of an Authorised Treatment Facility (ATF) dated **18 September 2023**, I enclose notification of SEPA's decision to grant approval of the ATF at the following site:

The approval allows you to issue evidence notes for Waste Electrical and Electronic Equipment (WEEE) received by or on behalf of the above site in the relevant period during which the approval remains in force. Please note that this ATF approval does not replace any other environmental authorisations that you already hold or require to hold for the site and you must still comply with these and other relevant legislation.

The approval is valid from **01 January 2024** until **31 December 2024** unless SEPA notifies you otherwise, or unless it is deemed to be cancelled under Regulation 64 (4) of the Regulations. Grant of this approval applies only to the named operator for the named site and is not transferable.

Any licences or permits for waste management operations or exemptions from waste management licensing that you hold must remain valid for the duration of the approval as the approval is dependent on the site being an ATF as defined in the Regulations i.e. a facility operated by an establishment or undertaking carrying out treatment and which is licensed or otherwise permitted under or by virtue of relevant UK legislation. Therefore, your approval will automatically be cancelled if the site ceases to be an ATF e.g. if its licence or exemption expires or is no longer valid.

If you wish to be approved in time for the start of the next compliance period commencing on **01 January 2025** so that you are able to issue evidence from that date, you should ensure that you apply to SEPA using the relevant application forms before **30 September 2024**.
