Any licences or permits for waste management operations or exemptions from waste management licensing that you hold must remain valid for the duration of the approval as the approval is dependent on the site being an ATF as defined in the Regulations i.e. a facility operated by an establishment or undertaking carrying out treatment and which is licensed or otherwise permitted under or by virtue of relevant UK legislation. Therefore, your approval will automatically be cancelled if the site ceases to be an ATF e.g. if its licence or exemption expires or is no longer valid.

If you wish to be approved in time for the start of the next compliance period commencing on 1 January 2022 so that you are able to issue evidence from that date, you should ensure that you apply to SEPA using the relevant application forms before 30 September 2021.
